As a State Representative, I receive a salary of \$79,650. This is determined by the State Officers Compensation Commission (SOCC).

There is an additional \$1,000 per month expense allowance. Legislators are also reimbursed for one round trip per week between their home residence and the Capitol Building. In my case this is \$136/week.
